



Proposed Vancouver opioid treatment program public hearing notice: *Washington State Department of Health asking for public input.*

The purpose of the hearing is for the public to provide comments about the proposed program as part of the licensing process required in state law. Comments provided are used to determine if the program meets licensing requirements and identify concerns that may need to be addressed. This is not a question-and-answer session. This hearing is free and open to the public.
