## SUBJECT: Standards for Designation of 988 Contact Hubs

Greetings Honorable Tribal Leaders and Tribal Partners -

In accordance with chapter <u>43.376 RCW</u>, the <u>Washington State Centennial Accord of 1989</u>, and <u>DOH</u> <u>Consultation and Collaboration Procedure</u>, we are inviting collaboration, in follow-up to our letter sent out in April 2023, for drafting the rules for designating 988 crisis centers. A part of the implementation activities for <u>HB 1477 Implementing the national 988 system to enhance and expand behavioral health</u> <u>crisis response and suicide prevention services</u>.

We will be hosting virtual workshops for our tribal partners to provide input on the draft rules crafted in part from listening sessions feedback earlier this year, including best practices across the nation. The rules will establish standards for the designation of crisis centers as "988 Contact Hubs" intended to improve the quality and consistency of care available for those who contact the 988 Suicide and Crisis Lifeline for support.
